Measures to support accessibility

Conformance status

It defines three levels of conformance: Level A, Level AA, and Level AAA. OFFICIAL NCOBRA.ORG is fully conformant with WCAG 2.0 level AA. Fully conformant means that the content fully conforms to the accessibility standard without any exceptions.
